\*\* Ratings are allowed to serve on Dutch flag ships when holding certificates (of proficiency) issued by the competent authority of an EU member state, EEA/EFTA member, a country of which the Netherlands recognizes the certificates pursuant to STCW Convention, Annex I, Regulation 10, or an IMO White list country (i.e. listed in [MSC.1/Circ.1163/Rev.x](#));

\*\*\* No rights can be derived from this list, the authority to recognize a certificate remains with the administration of the Netherlands;
